Reported that the season ended with 64 new members, 414 renewed, 16 commercial, total 494 members. Twenty-one more than last year. June 30, 2022, is the official end of the season per AWSC. There will be a notice in the June newsletter for signing up for the 2022-2023 season which official begins July 1, 2022. The \$35 fee for membership will remain the same.

Scott reported that the sheriff's department had put in 226 hours this season. 28 citations. 12 warnings. 20 accidents. One fatal. 6 OWI

AWSC News: Scott Swendson

586 people attended the AWSC youth auction in Green Bay. 32 youth. Raised greater than \$9,000. NLSC was recognized for the most increase in commercial members. We are the fifth largest snowmobile membership group.

486 new trails due to trail pass monies. Land use agreements being worked on. All citations must be approved by the landowner. AWSC has increased the money for law enforcement and are constantly working on this.

It was approved by the membership that once Dave is comfortable that all the seasons' financials have been accounted for, a donation amount that leaves a minimum of \$4,000 in our account will be given to the Trails org.

Reg announce that NLSC is co-sponsoring live music that will follow the TL- BRT golf event on May 21 at the Big Stone golf course. This will be half of the cost of the music.

Reg announced that NLSC will host the Rome Sno-Bandits from Adams County in late January as part of their overnight ride event. They will look for us to lead them to some of our favorite ride destinations. Other plans for NLSC hospitality will be planned.

Reg made a very special attempt to personally thank every board member/committee chair/volunteers/And several individual people for the outstanding jobs they have done for the NLSC club. Reg was also recognized for his and Karen's dedication/hard work /commitment/leadership and personal support and time as the president of our club.
